

### BROKER DISCLOSURE TO NON-RESIDENTIAL CUSTOMERS

Prior to negotiating on your behalf the Broker must provide you the following disclosure statement:

#### 2 BROKER DISCLOSURE TO CUSTOMERS

- 3 You are a customer of the broker. The broker is either an agent of another party in the transaction of a subagent of another broker
- who is the agent of another party in the transaction. The broker, or a salesperson acting on behalf of the broker, may provide
- brokerage services to you. Whenever the broker is providing brokerage services to you, the broker owes you, the customer, the 6 following duties:

- 13 The duty to protect your confidentiality. Unless the law requires it, the broker will not disclose your confidential information or the confidential information of other parties (See Lines 22-39). 14
- 15 The duty to safeguard trust funds and other property the broker holds.
- The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the advantages and 16 disadvantages of the proposals. 17
- Please review this information carefully. A broker or salesperson can answer your questions about brokerage services, but if you 18 need legal advice, tax advice, or a professional home inspection, contact an attorney, tax advisor, or home inspector. 19

- the party's decision to enter into a contract or agreement concerning a transaction or affects or would affect the party's decision 50
- about the terms of such a contract or agreement. An "adverse fact" is defined in Wis. Stat. § 452.01(1e) as a condition or occurrence that a competent licensee generally recognizes will significantly and adversely affect the value of the property, significantly reduce
- the structural integrity of improvements to real estate, or present a significant health risk to occupancy of the property; or information
- that indicates that a party to a transaction is not able to or does not intend to meet his or her obligations under a contract or
